






Inside the foyer

Operational Support Cancellation Policy

1. How to Request a Cancellation

If you wish to cancel your exhibition participation, the applicant must email the following information: Company name / Contact person / Exhibition category (Booth / Advertisement) / Reason for cancellation

2. Cancellation Fees

The following cancellation fees apply based on the date of notice:

Up to 90 days prior (by February 9, 2026): 50% refund

89 to 30 days prior (February 10 – April 9, 2026): 30% refund (70% cancellation fee)

Within 29 days (April 10, 2026 – event day): No refund

Bank transfer and refund processing fees are the responsibility of the exhibitor.

The same conditions apply for advertisement-only participation.

3. Refund Processing Period

If a refund is applicable, it will be processed within 14 business days after cancellation approval.

4. Force Majeure

If the event is canceled due to natural disasters, infectious disease outbreaks, government directives, transportation disruptions, or other unforeseen circumstances, refund eligibility and percentage will be determined by the organizer.

5. Transfer of Exhibition Rights

Transferring exhibition rights to a third party is strictly prohibited.

6. Changes to Exhibition Content

If you wish to make significant changes to your exhibition content from what was originally submitted, prior approval is required.

Unauthorized changes may result in cancellation of your exhibition participation.

Frequently Asked Questions (FAQ)

Can I sell products?

→Yes, product sales are permitted.

Can I use my own payment terminal?

→Yes, you may use your own device. Please bring your own extension cord.

Can multiple people operate one booth?

→Yes, that is allowed. Shift-based operation is also acceptable.

Can I distribute samples?

→Yes, you may. Please comply with the venue's safety and hygiene guidelines.

Are there rentals for fixtures or equipment?

→Aside from one table, two chairs, a navy tablecloth, and garment racks (limited quantity), no other fixtures or equipment are available. Please bring any additional items you require. The total display area, including the table, must fit within 180 × 100 cm.
